

Dear Student and Parent/Guardian.

The Bibb County School District is providing every student a device to use at school. Each student may take this device home under the condition that a parent has completed the **STUDENT DEVICE USE CONTRACT (ON BACK)**. He/she will take proper care of the device and return to school each day with **BOTH** the device and charger while receiving face-to-face instruction. If any damage occurs or the device is lost or stolen, it must be reported immediately to the school. A copy of the contract will be provided to the student.

Parents may choose to use their own device at home and only use the student-issued device at school. **ALL STUDENTS** must agree to use technology responsibly whether at school or at home by signing the **TECHNOLOGY USE AGREEMENT** below.

Please indicate whether or not you would like your child to take home the school-issued ipad (Apple 7 Gen \$299 ipad + \$99 case) or Dell 3190 laptop (\$463 laptop + \$12 sleeve).

Yes, I would like to take home an ipad/new laptop. To get a new laptop, I must return both the previously issued laptop and charger with no damages and complete a new Student Device Use Contract **ON BACK**.

No, I would prefer to use my own device at home. I will follow the rules for using the school-issued device at school.

### TECHNOLOGY USE AGREEMENT

- I understand that my parents will have to pay for any BCSD's property damaged, misplaced or lost by me.
- I understand I will need to return the technology on the due date as required.
